### Rating Action: Moody's Ratings affirms Welltower's A3 rating, changes outlook to positive

New York, February 26, 2026 -- Moody's Ratings (Moody's) today affirmed Welltower Inc.'s A3 long term issuer rating, as well as the A3 long term issuer rating, senior unsecured, backed senior unsecured notes ratings and the P-2 rating on the commercial paper program of Welltower Inc.'s subsidiary, Welltower OP LLC. We also affirmed the A3 backed senior unsecured rating of HCN Canadian Holdings-1 LP. We refer to Welltower Inc., Welltower OP LLC and HCN Canadian Holdings-1 LP collectively as "Welltower" or "the REIT". We changed the outlook on all entities to positive from stable.

The change in outlook reflects our expectation that Welltower's revenue and earnings will continue their strong growth and that the REIT's metrics will continue to improve materially over the next twelve months. A key driver of today's rating action is Welltower's financial policy, which has focused on organic growth and equity-funded investments to grow earnings, leading to a rapid deleveraging of the capital structure.

#### RATINGS RATIONALE

Welltower's A3 senior unsecured ratings reflects the REIT's large scale combined with quality assets and its high revenue growth portfolio that includes a mix of senior housing operating (SHOP), senior housing triple-net leased assets, and long-term/post-acute care facilities. The A3 ratings are also supported by the REIT's commitment to maintaining a relatively conservative capital structure, as evidenced by the large proportion of equity used to fund acquisitions. Welltower benefits from strong demographic tailwinds (the aging population), which underpin long-term demand for senior housing. We expect Welltower's net debt/EBITDA, which stood at 3.8x on an LTM Moody's adjusted basis at year end 2025, to decline to around 3.4x by the end of 2026 while interest coverage will remain above 5x.

Welltower's A3 ratings also reflects the REIT's high exposure to the SHOP segment which, following the recent disposition of the outpatient medical portfolio, will represent more than 70% of annualized in-place net operating income (NOI) going forward. While we expect the increase in the addressable demographic to be supportive of demand, senior housing operations rely on short term leases with high tenant turnover in a business with high labor-related fixed costs.

Welltower's net debt/EBITDA (Moody's adjusted) was 3.8x at year-end 2025, down from 4.6x at year-end of 2024. While the bulk of the improvement in the REIT's capital structure comes from growth from mostly equity-funded acquisitions, organic growth has also been very strong, particularly in the REIT's SHOP segment. In 2025, Welltower recorded same store NOI growth in its SHOP segment of 21.5%. This was a result of improved occupancy, increased revenue per occupied room, and controlled expense management.

We expect demand for senior housing to remain at an all-time high in the coming years as the ageing Baby Boomer generation leads to an acceleration in the growth of the addressable market for Welltower and its peers.

Welltower's liquidity is excellent. As of 31 December 2025, the REIT had approximately \$5.2 billion of cash on hand and full availability under its \$5 billion revolving credit facility. The REIT has \$700 million of unsecured debt coming due in 2026.

The positive outlook reflects the improvement in Welltower's operations, and our expectation that the company will continue to strengthen its financial metrics through earnings growth and a conservative approach to investments.

## FACTORS THAT COULD LEAD TO AN UPGRADE OR DOWNGRADE OF THE RATINGS

Welltower's ratings could be upgraded on the back of continuing strong operating performance, and the REIT building a track record of operating at a net debt to EBITDA below 3.5x and fixed charge coverage above 5.5x.

Downward rating pressure could occur should net debt/EBITDA increase and be sustained above 5x, or should there be a reversal in the fundamentals underpinning our expected growth in the REIT's SHOP segment.
